Transformation

The Purpose of contrast is the aspect of the curriculum I use with this modality: Knowing the deeper meaning and significance of all things, beyond logic and reason.

Vision

As I conscious innovator, I am bringing the future into the present by releasing what is harmful and using my inherent power to liberate and heal.

The challenge of this modality is to remain committed to a new vision long enough to see it come to fruition, which may involve dismantling systems and structures so that new life can emerge.

The lesson I bring to the world is to believe in a vision, however great or small, and to use creative potential to change lives.

The Polarity of contrast is the aspect of the curriculum I use with this modality: Knowing wisdom through the experience of contrasts, beyond logic and reason.

Passion

This compromises all fears and issues of low self-esteem that are the cause of choices that undermine empowerment and success.

The Cause-Effect of contrast is the aspect of the curriculum I use with this modality: Positive consequences of following and acting on my inspiration.

As a conscious innovator, I smooth relations between waring groups or individuals, and forge alliances and connect disparate groups.

The challenge of this modality is to understand the issues on both sides of a conflict and work to bring all parties together to resolve it.

The lesson I bring to the world is to lead an exemplary life based on wisdom and temperance in my dealings with others, awaken the need to forgive, and be socially flexible and empathetic which allows for finding commonality with all sorts of people.
